What is the yearly value of the spending card?



\$1,200 associate only



\$2,400 associate + spouse/domestic partner or child(ren)



\$3,000 family



Is this benefit taxable?

Yes, the value of the Nutrition Kit will be considered income on your tax return. To help make sure you receive the full benefit amount, Anthem will increase the wages reported on your W-2 and withhold the estimated taxes for you.



Is there an app to use for this?

The Nutrition Kit comes with a free mobile app where you can check your benefits, find a grocery store near you, and see the list of approved groceries you can use Nutrition Kit funds to buy. You can also use the app to pay for groceries at the store by scanning the barcode on it. Download the app here.



Can I use my funds at any grocery store?

You can shop at more than 22,000 participating retailers nationwide,* including Kroger, Ralph's, Smith's, and Walmart.com delivery. Use the Nutrition Kit mobile app or visit **healthybenefitsplus.com** to see where you can shop near home or work.
